El Paso Electric Solar Photovoltaic System Pre-Qualification STATEMENT OF QUALIFICATIONS (SOQ)

Statement of Purpose

El Paso Electric Company ("EPE") is currently seeking to pre-qualify interested parties ("Party") capable of providing renewable energy services including: design, installation; commissioning; operation; maintenance; and ownership for a 20MW solar photovoltaic system ("PV services"). The solar PV system is expected to be located on land within the Fort Bliss military reservation in the El Paso, Texas area.

EPE expects to issue a Request for Proposal ("RFP") at a later date to secure the listed PV services. The RFP will be issued to the pre-qualified parties, after which EPE expects to negotiate up to a 25 year Purchase Power Agreement ("PPA") with the selected bidder for the purchase of the energy from the system over a specified term period. EPE expects to enter into a multi-year agreement for the term of the PPA with the US Army to serve Fort Bliss with a reliable source of renewable energy.

EPE expects to receive a Statement of Qualifications ("SOQ") submittal from each interested party that provides all the information requested and reflects the capabilities of each individual party. Responses submitted as part of this SOQ must be concise and formatted in accordance with the sequence noted below. The SOQ should be mechanically bound and should be limited to not more than 30 (8.5 inch X 11 inch) pages, printed on both sides, excluding covers and dividers. Dividers should separate each section of the SOQ, and the tabs should be labeled with the section numbers listed below.
