



NOTICE TO EPE CUSTOMERS

El Paso Electric Company (EPE) filed its annual Renewable Energy Plan (Plan) in a proceeding with the New Mexico Public Regulation Commission on May 1, 2025 (Case No. 25-00038-UT).

NO ACTION REQUIRED. PARTICIPATION IN THE PROCEEDING IS VOLUNTARY.

The application requests that the New Mexico Public Regulation Commission approve:

- EPE's 2026 Plan Year, including the information and data for the 2027 Plan Year.
- The purchase and flexible allocation of 100 percent of the renewable energy generated from the Santa Teresa Project in 2026 and purchase and include 50 MW of the battery energy storage component of the project.
- The recovery of Commission-approved 2026 Plan procurement costs through the RPS Cost Rider.
- A reconciled RPS rider costs and rider revenue collections for calendar year 2024.
- A revised RPS Cost Rider Rate No. 38 monthly rate from \$0.015742 per kilowatt-hour ("kWh") to \$0.020215 per kWh, to recover approved 2026 Plan Year costs adjusted for the 2024 reconciliation.
- A variance from the data filing requirements of 17.9.530 NMAC; and such other approvals, authorizations and actions required to implement the Plan and revisions to the RPS Cost Rider.
