

Evaporative/Refrigerated Air Rebate

Texas Residential & Income Qualified Solutions Programs

1. Program Overview

- El Paso Electric will pay out a rebate to eligible customers within EPE's Texas service territory that install an **eligible evaporative cooler or refrigerated air conditioner (including heat pumps and mini splits)**
- Rebate will be available through December 31, 2026, or upon funding availability. Rebate amounts are subject to change.
- Customers may hire a contractor of their choice, or they may choose to do the work themselves.
- For a refrigerated air conditioner rebate, the contractor must be a licensed HVAC contractor OR the contractor must have an air conditioning and refrigeration contractor license
- Evaporative Cooler rebates for single-family homes may vary due to limited-time promotions, offering **up to \$900** for residential customers and **up to \$1,000** for income-qualified customers.
- Rebates **up to \$449.00** (this example applies to a new Refrigerated AC between 54,000-64,999 BTU/h and 15.2 SEER2, 12 EER2 replacing an old Refrigerate AC)
- If the total project cost is less than the rebate amount, the rebate will equal the total project cost.

2. Customer Eligibility

- Customer *must* reside in Texas and receive electric service from EPE.
- To qualify for enhanced incentives through our Income Qualified Energy Efficiency Program check the Income Eligibility Form found at <https://www.epelectric.com/energy-efficiency/texas-residential-energy-efficiency-programs>
- Customer must qualify through categories 1A, 1B or 1C. Category 2 is not eligible.
 - Category 1A - Provide proof.
 - Category 1B - Confirm during funding reservation.
 - Category 1C - Check at www.huduser.gov/portal/sadda/sadda_gct.html.

3. To Qualify

- New Equipment **MUST** be purchased and installed in the current program year.
- Evaporative Coolers must be listed on the Eligibility List (pg. 2) to be eligible for a rebate.
- Refrigerated Air Conditioners must have an AHRI certificate to be eligible for a rebate and meet minimum efficiency program requirements <https://www.ahridirectory.org/Search/SearchHome>
- Equipment Must be permanently installed with a single duct or ducted air distribution system (except for mini-splits)

4. Program Funding

- This program has limited funding. Rebates are awarded on a first-come, first-served basis.

5. Submit Required Documentation for Payment of Project

- Submittals will be made through email at epe.residential@cleareresult.com mailed to CLEAResult at **311 Montana Ave A-2 El Paso, TX 79902** or through online customer portal at <https://epe.cleareresult.com/>
- Customer must submit the following documents within the 45-day period starting from the invoice date.
 - **Application Form.**
 - Manufacturer, model trade/brand name, model and serial numbers must be listed on the application form.
 - Release of liability for both El Paso Electric and CLEAResult included.
 - **Photographs of installed system, nameplates, and invoice/store receipt**

6. Project Notification/Schedule Inspections

- Once the rebate application is submitted, El Paso Electric and/or CLEAResult may perform an inspection to confirm project completion before paying out incentive. Inspections take 15 to 20 minutes and are scheduled during office hours; M-F, 8:00 am – 5:00 pm.
