Texas Residential & Income Qualified Solutions Programs

1. Program Overview

- El Paso Electric will pay out a rebate to eligible customers within EPE's Texas service territory that install **ceiling and wall insulation**.
- Rebate will be available through December 31, 2026, or upon funding availability.
- Customers may hire a contractor of their choice, or they may choose to do the work themselves.
- Rebate amount depends on existing level of insulation and square footage indicated as living area in the El Paso Appraisal Department <https://epcad.org>
- Rebates **up to \$0.36** per sq.ft. (this example applies to a house with refrigerated air cooling and 1 inch of ceiling/attic insulation or less)
- If total project cost is less than the calculated rebate amount, the rebate will equal the total project cost.

2. Customer Eligibility

- Customer *must* reside in Texas and receive electric service from EPE.
- Single Family Homes only (1-4 units in one location).
- To qualify for enhanced incentives through our Income Qualified Energy Efficiency Program check the Income Eligibility Form found at <https://www.epelectric.com/energy-efficiency/texas-residential-energy-efficiency-programs>
- Customer must qualify through categories 1A, 1B or 1C. Category 2 is not eligible.
 - Category 1A - Provide proof.
 - Category 1B - Confirm during funding reservation.
 - Category 1C - Check at www.huduser.gov/portal/sadda/sadda_gct.html.

3. To Qualify

- Ceiling insulation existing R-value must be less the R-22 (less than 7 inches)
- Ceiling insulation post R-value must be at least R-30.
- Wall insulation existing R-value must be at least R-4 (less than 1.5 inches) Wall insulation post R-value must be R-13 (2x4 wall) and R-17 (2x6 wall)

4. Program Funding

- This program has limited funding. Rebates are awarded on a first-come, first-served basis.

5. Submit Required Documentation for Payment of Project

- Submittals will be made through email at epe.residential@cleareresult.com mailed to CLEARResult at 311 Montana Ave A-2 El Paso, TX 79902 or through online customer portal at <https://epe.cleareresult.com/>
- Customer must submit the following documents within the 45-day period started from the invoice date.
 - **Application Form.**
 - Insulation type, starting R-value, post R-value and square footage
 - Release of liability for both El Paso Electric and CLEARResult included.
 - **Photographs of area before insulation installation, of insulation thickness using a ruler/tape, of area after insulation installation and of insulation thickness using a ruler/tape. Copy or Photograph of invoice or receipt.**

6. Project Notification/Schedule Inspections

Once the application is submitted, El Paso Electric and/or CLEARResult may perform an inspection to confirm project completion before paying out incentive. Inspections take 15 to 20 minutes and are scheduled during office hours; M-F, 8:00 am – 5:00 pm
