APPLICABILITY

This Federal Tax Credit Factor ("FTCF") is applicable to all customers taking service under a retail rate listed below.

In compliance with the New Mexico Public Regulation Commission order in Case No. 20-00104-UT, El Paso Electric Company (EPE) is to return to customers an amount that reflects the impact of the federal corporate tax rate reduction established in the Tax Cuts and Jobs Act of 2017 on EPE's accumulated deferred income taxes. Customers entering the Company's system during the term of this schedule will receive the refund credit in billings from their entry date. Customers leaving the Company's system during the term of this schedule will receive the credit through their exit date within the timeframe allocated in this schedule.

TERRITORY

Areas served by the EPE in Doña Ana, Sierra, Otero and Luna Counties.

TERM

This FTCT shall continue for a period of three (3) years from the effective date of this schedule.

MONTHLY RATE FACTOR

The FTCT reflected in this tariff is calculated for each rate class as a percent (%) factor and then applied to the non-fuel base rate charges of the customer bill. The Tax Adjustment provision of each rate schedule will apply to the resulting adjusted non-fuel base rate charges. The reduction will appear as a separate line item on the customer's monthly bill and shall be titled "Federal Tax Credit".
