APPLICABILITY

This Rate Case Expense Surcharge is applicable to customers taking service under the rate schedules listed below as either a \$/kWh factor applied to billed energy or as a directly assigned amount.

TERRITORY

Texas service area.

MONTHLY CHARGE

Pursuant to the Final Order in Docket No. 46831, the Company is authorized to surcharge customers to recover the rate case expenses pursuant to the docket. The surcharge is calculated for each rate class below as either a \$/kWh factor applied to billed energy or as a directly assigned amount. The surcharge shall appear as a separate line item on the customer's monthly bill titled "Rate Case Expense Surcharge." The surcharge shall continue for a period of thirty-six (36) months from the effective date of this schedule of January 10, 2018, provided that the Company shall cease billing the surcharge in the month that the total approved amount has been collected. Upon cessation of billing, the amount of any over-recovery or under-recovery of the approved rate case expense surcharge amounts by rate class shall be included in the deferred fuel balance for that class as a refund or surcharge. Customers entering the Company's system during the surcharge period will receive the surcharge in billings from their entry date. Customers leaving the Company's system during the surcharge period will receive the surcharge through their exit date.
